## New Playground Equipment:

The City Council approved the purchase of a new piece of playground equipment for the city park. A 10 foot Merry Go Round has been ordered and depending on the delivery date it will possibly be installed yet this fall. The cost of the Merry Go Round including freight is \$6,829. The Booster Club generously donated \$500 towards the purchase. Approximately, \$3000 will be coming from the city's Cans for Kids fund. The

remaining amount will be paid for from the City's general fund and was included in the 2014 budget.

## **BURN SITE CONTINUES TO BE MISUSED:**

The city's burn site permit is issued and inspected by the MN Department of Natural Resources, pursuant to MN Statute Chapters 88.17 Subd. 3 (b) and 88.171. The permit allows for the open burning of **trees, tree trimmings and brush** at the site. When the site is misused by the dumping of items other than what is allowed our site could be in jeopardy of having it's permit revoked. Furniture and treated wood items are not allowed and must be removed prior to burning the pile.

## **Sunday Liquor Question To Be Placed On November Ballot:**

A request was made by Jakes Bar and Grill to pose the question to the voters of the City of Belview to allow them to be open on Sundays. Minnesota Statute allows bar/restaurants to be open on Sundays but requires that the question be decided by the majority vote of the municipality's voters. The question will read as follows:

*Shall the City Council be allowed to issue on-sale licenses to restaurants, clubs, bowling centers and hotels for the sale of intoxicating liquor at retail on Sundays?*
