

## CITY OF BELVIEW

March 8, 2016

The City Council of the City of Belview met for their regular monthly meeting on March 8, 2016 at the Odeon Hall, Belview, MN at 6:30 p.m..

Mayor Sander called the meeting to order at 6:30 p.m.. The consent agenda was approved by a motion Myrle Peterson seconded by Dianne Donner.

Heaven's Gate Winery owners, Bill and Bonnie Marhoun requested the approval of an on sale and Sunday Liquor license for a 6 month period from May 15<sup>th</sup> until November 15<sup>th</sup>. Their request was granted by a motion from Janet Anderson which was seconded by Myrle Peterson. Motion carried. Discussion was also held on the need for a new water connection for the winery which is being mandated by the Dept. of Health.

The City Council agreed to move ahead with a safety grant through the Dept. of Labor and Industry for making the city clerk's office more secure. The grant is a 50/50 match. They also said to do whatever was needed to make the office safer even if it is not covered under the safety grant.

The fire contract between the City of Delhi and the Belview Fire Department is set to begin July 2016.

Janet Anderson made a motion which was seconded by Linda Sullivan to approve the adoption of an ordinance extending the term of the existing cable television franchise with Hanson Communications of Clara City, MN. There were no modifications or changes to the existing franchise. The new franchise expiration date is July 1, 2029. All members voted in favor of the motion.

Spring Clean up has been set for May 7<sup>th</sup> and will be run the same as in previous years.

David Diekmann had Dakota Supply give him a estimate on fixing the controls in the water plant. David Diekmann told the council that Ervin Well has informed him that it is time to inspect the north well as the last time it was done was 2010. David will schedule them to come out.

David Diekmann will be working on grading the alleys.

He was asked to get a cost of doing an overlay on the park road when the crew is in town doing Second Street.

Redwood Co. Comprehensive Water Management Plan meeting is going to be Thursday April 7<sup>th</sup>. David Diekmann is planning on attending.

Linda Sullivan made a motion which was seconded by Myrle Peterson to approve a resolution to contract with a councilmember. The city contracted with Sander and Sons for snow removal when David Diekmann was attending the MN Rural Water conference in St. Cloud. Carried.

Linda Sullivan gave the Parkview/Parkwood report.

Gambling resolutions for the American Legion and the Belview Fire Relief Association were approved by a motion from Janet Anderson and seconded by Dianne Donner. Carried.

Janet Anderson made a motion to adjourn the meeting. The motion was seconded by Dianne Donner. Carried.
