May 10, 2011

The City Council of the City of Belview met for a regular monthly meeting on May 10, 2011 at the Community Center, Belview, MN at 6:30 p.m..

Mayor Marlo Sander called the meeting to order at 6:30 p.m.. Consent agenda was approved by a motion from Janet Anderson and second by Myrle Peterson. Approved.

Mike Uhlenkamp, of Uhlenkamp and Assoc. presented the 2010 audit. The City Council will review the audit and it will be approved at the June meeting.

Duane Day of Negen Architects presented a floor plan and cost estimates for the Odeon Hall Renovation project. The City Council made a motion to begin the bidding process by a motion from Myrle Peterson and it was seconded by Janet Anderson. Carried.

Environmental violations were discussed. Letters will be sent to a couple of property owners by the city attorney.

Report was given on visit to St. Johns Grandkids Daycare facility and also on legislative visit to Parkview Home.

Information was discussed regarding blue information signs that the county will make for us and can be placed on Highway 19 and also, replacing the Welcome to Belview signs with something more colorful. Correspondence from the State regarding population signs was also discussed.

A Certificate of Commendation for Wastewater treatment facility staff for 2010 received from MPCA.

A Good Morning Telephone Reassurance Calls Program that is starting here in Belview was discussed.

City Maint. David Diekmann received permission to purchase a new metal detector.

David Diekmann reported that he had started putting up the mini golf course in the park. He also noted that Stan Johnson agreed to make the needed repairs to some of the structures.

David Diekmann shared the annual water report from MDH.

He informed the council that Grace Lutheran was asking about the removal of trees on the north side of the church building. It was noted that the church planted them so they can remove them. The city does not require trees to be put back in to replace them.

Chad Krinke was given permission to mow the hay at the ponds. A release of liability will be required.

City Clerk Lori Ryer shared the conversation with Chuck Veermeersch what SEH has done so far. A street reading has been done and he suggested that televising needs to be done as it was noted that the last time it was done was in 1993.

Janet Anderson stated that she had been asked about the diagonal parking on Main Street on Sundays. It was noted that the parking issues were the County Highway Department's jurisdiction because it is a county road.

Linda Sullivan made a motion which was seconded by Janet Anderson to approve a building permit for moving a shed into town and a fence permit for a dog kennel. Approved.

The meeting was adjourned by a motion from Linda Sullivan and it was seconded by Janet Anderson.
