June 8, 2010

The City Council of the City of Belview met for their regular monthly meeting on June 8, 2010 at the Community Center, Belview, MN at 6:30 p.m..

PRESENT: Mayor Marlo Sander, Council Members: Dianne Donner, Janet Anderson, and Linda Sullivan and Myrle Peterson

Mayor Sander called the meeting to order at 6:30 p.m.. The consent agenda was approved by a motion from Myrle Peterson and was seconded by Janet Anderson. Carried.

Mike Uhlenkamp, Uhlenkamp and Associates presented the 2009 audit report. The Council was asked to review the audit and report back to Lori at the City Clerk's Office or directly to him if there were any questions before June 30th.

The City Council discussed a couple of sink holes that we have to repair.

Myrle Peterson made a motion which was seconded by Linda Sullivan to approve the following as election judges; Joanne Aamoth, Dianne Donner, Jan Eilers, Julie Faugstad, Jan Omtvedt, Michelle Schneider, Margaret Sander, Donna Thomas. Carried.

Marlo Sander made a motion which was approved by Janet Anderson to approve Dianne Donner to the Parkview Board for a three year term. The Council also noted their appreciation to Sharon Biastock for her service on the board.

Discussion was held on the work down by Visu-Sewer. They lined sections of the city's sewer system that were experiencing problems. Lori Ryer shared pictures of the process. The work that was done comes with a 50 year warranty.

Lori Ryer updated the City Council on the status of the property that has been requested to hook up to city sewer. A citation was to be issued but as of the council meeting date the citation had not issued. Mayor Sander will contact the city attorney again. This is to be top priority.

Infrastructure improvements were discussed and the council directed Lori Ryer to check with an engineer to look at possible options. It was decided to give Lori Ryer the authority to work with an engineer to get rough cost estimates to begin the process. This was approved by a motion from Janet Anderson and was seconded by Dianne Donner.

A quote was received from Bargaen Inc. for asphalt pavement maintenance through out the town. No action will be taken at this time until more discussions with an engineer.

The City Council agreed that for the time being the bad spots in a couple of city streets will be dug out by David Diekmann and filled with granite fines.

A request for was made for the City Council to purchase additional flags for the street poles on Main Street. A motion was made by Dianne Donner and was seconded by Linda Sullivan to buy 15 flags from the American Legion.

The insurance claim from the lightning damage was discussed. Even though there were three buildings affected in was only considered one claim so there will only be one deductible. There was damage to the water plant, router for wireless internet in the City Clerk's Office and the siren on top of the Odeon Hall. Everything had been fixed except the water plant. Farmers Coop Electric is still waiting for parts.

Dianne Donner offered to help look for a good deal on a new printer for the City Clerk's Office.

Lori Ryer was asked to get prices for some new banquet tables for Odeon. David Diekmann was asked to get prices on new picnic tables.

A donation of 25 chairs was received from the Myrle Peterson family for the Odeon Hall.

David Diekmann was asked to remove the timbers around the playground equipment. The City Council requested that the City Maint. Dept. do some sprucing up in the city park.

The bathrooms next to the Odeon were discussed. They are to be opened up ASAP. The privacy fence is to be removed. Trees need to be trimmed also. A light has been installed on the Odeon Hall to light up that area.

A Sick and Vacation report was reviewed.

The City Council reviewed a list of projects for the Maintenance Dept..

David Diekmann informed the City Council that he is going to be gone from June 17-23. He will contact Curt Sander to cover for him and a list will be left for Nathan Johannsen.

Linda Sullivan gave a Parkview/Parkwood report.

A walk through of city shop was done by the council. As part of the City's new safety program they will be having a mock OSHA inspection on June 29th of City property.
